Demand drafts of preferably State Bank of India or Jammu & Kashmir Bank Ltd payable at Jammu be submitted.
3. The local SSI unit holders shall have to furnish the latest functional status and Existence certificate of their units from the concerned D.I.C, PAN No, Proof of Power sanction & Power Dues clearance certificate at the time of purchase of tender documents.
