

Terms and conditions can be had from the office of the Superintending Engineer, Electric Purchase Circle-I, Jammu / Superintending Engineer, Electric Purchase Circle-II, Srinagar against cash payment as shown above for firms outside the state and Rs 100/- (Non refundable) for the local SSI units or in the shape of Demand Draft in favour of Superintending Engineer, Electric Purchase Circle-I, Jammu. Demand drafts of preferably State Bank of India or Jammu & Kashmir Bank Ltd payable at Jammu be submitted.
3. The local SSI unit holders shall have to furnish the latest functional status and Existence certificate of their unit from the concerned D.I.C, PAN No, Proof of Power sanction & Power Dues clearance certificate at the time of purchase of tender documents.
4. The firms located outside the state will have to submit proof of Permanent Registration with DGS&D or NSIC or Department of industries of the State or Central Government, PAN No. along with the requisition for issuance of tender document.
